Various committees are already bustling about selling advertising, taking photos of homes, organizing docents, and performing a myriad of other activities associated with the tour. We need your help to make this year's tour a success. Tour proceeds are split equally between the Riley County Historical Society, for its work to preserve the Wolf House Complex, and the Manhattan/Riley County Preservation Alliance, which is dedicating its proceeds to rehabilitating Manhattan's Union Pacific Depot.

Preservation Alliance members have probably noticed the renovation activity surrounding the depot. To date these include: stabilization of the structure, removal of hazardous materials including lead based paint and asbestos, and replacement of the tile roof. However, much more work needs to be done. Currently the building is vacant, without heating or cooling facilities or restrooms. Moneys earned from this year's homes tour will be put to good use in the depot restoration.

Finally, I would like to remind members and potential new members that membership dues are currently \$15 per person or \$20 per family.
